





- AMMASA must maintain the required levels of insurance being \$10 million Public Liability Insurance and \$5 million Professional Indemnity Insurance
- AMMASA must advise the Combat Sports Authority of any significant changes in its rules, policies, operations or financial position as they occur
- AMMASA must set up financial reporting based on a standard chart of accounts within 12 months, and
- AMMASA review current waivers and releases on membership information within 12 months.

The Combat Sports Authority will contact you shortly to discuss the arrangements in place for the conduct of combat sport contests in 2015.
